## **<u>CHARITABLE</u> – BOWERS**

#### **GOVERNMENT RELATIONS** – SWAIL

• We have engaged the Pickering Local because the Pickering riding now includes Brooklin. We would like to assist our brothers and Sisters in Pickering instead of engaging candidates specifically on our end, so we don't have a conflict of interest.

## **<u>GRIEVANCE</u> – FRIEL**

- 23-004 Benefit Grievance next arbitration date for fall.
- 24-001 Attendance Support Program Grievance
  - Referred to arbitration, first date is Sept 2025
- 25-001 AD&D Grievance Employer denied paying Al Marchand's estate his AD&D entitlement. We filed a grievance, and we are proceeding straight to arbitration. Waiting for the lawyers to set dates. Engaging some other locals to see who has the best case and then the best case will go first. Potentially Mississauga or us going first.
- Filed another grievance today about medical certificates. Association does not think that sick notes should be automatic, and willing and able persons shouldn't have to use sick time while awaiting a doctors appt to obtain note.

### **NEGOTIATIONS** – FRIEL

- Met for 2 weeks, went very well, during monetary negotiations they stalled due to recommendation from OPFFA, waiting for Torontos arbitration, Ottawa arbitration, and Oshawa. These locals might get frontline pay. Trend amongst the province with salaries is active right now. What is potentially coming is not what the town was going to give us. Town agreed to pause which will work in our benefit. Putting things on pause until Toronto (anytime), Ottawa(anytime), Oakville me to clause with Halton Hills. Oshawa arbitration Apr 24 plus 90 days longest until we have a better understanding.
- Made some changes with clothing LOU with town. No additional clothing will be provided from the vendor that was recently chosen for the remainder of 2025. All new pants issued will be returned and given to recruits. New vender NLT Dec 31 2025 will give all WFES pers 2 new shirts and one pair pants. Active wear shorts by Dec 31 2025. NLT Mar 31 2026 all members will get 2 full sets. WFES personnel will have 3 full sets complete by Mar 31 2026. After this the regular clothing distribution will commence.
- Glenn Gear asked question about how much the dress policy affected bargaining. Friel said that the negotiations committee

asked for all the new items that were included in their new dress policy to be provided items. Management didn't agree with all items.

#### **UNFINISHED BUSINESS** – FRIEL

- Canteen Manager, brother Linton successfully appointed to canteen manager position. In charge of all canteen items.
- May association meeting will be in person.

#### <u>NEW BUSINESS</u> – FRIEL

- Management served association with a 60 days' notice for cancelling the LOU about duty exchanges. Management declined having new language put into CA. Current LOU null and void May 26, 2025. Management will have policy about duty exchanges. Association will have zero control since the LOU will be cancelled. If you need dates in 2025 to be covered, you should move on them.
- Employer has moved to online textbooks. If you need one for a course, you're on, make the request early.
- Neil question about duty exchanges and if current ones on the schedule would be cancelled? Friel doesn't believe they will but if they do, please notify a member of the executive.
- Bowers comment about online textbooks. And Microsoft office at home not being provided.
- Friel says members should request that software to management.
- Member with accommodation request did not hear back for textbook request.
- Johnson training division is trying to acquire as many laptops as possible.
- Pannunzio training division does have the ability to sign out laptops for courses, and we have signed them out in the past. If you require any of these, we can get it for you.
